- One (1) years dues (\$10.00) must accompany this application
- Dues for applications received <u>September through November</u> are \$5.00. December applications with dues (\$10.00) are considered paid in full for the upcoming year
- Applicants under the age of 16 who wish to join as an Active cadet fire fighter must have a parent or guardian sign a permission form for membership and if applicable, a permission for provided by the Captain to extend curfew hours during weekdays (as required by PA Child Labor Laws).
- Company meeting night is the first Thursday of each month at 8:00 PM. Drill night is every Thursday at 6:30 PM.
- Any new member must sign the Rolls of the Company and Firemen's Relief Association of West Chester Rolls within two (2)
 months in order to officially become a member of the Fame Fire Company and receive all benefits for which you are
 entitled. Beneficiary cards are provided at that time to be completed and kept on file with the Company
- New members will be provided a copy of the Constitution & By-Laws and House Rules. It shall be the duty of all members to comply with the rules set forth by this organization and conduct themselves in a professional manner at all times.
